

Law on Civilian Invalids of War (1996)

"Civilian invalid of war is a person who has suffered physical damage of at least 50% due to a wound, injury or lesion that left visible traces occurred from the abuse or imprisonment by the enemy during the war, performing war operations, remaining from war enemy's sabotages materials on or terrorist actions".

Basic Principles and Guidelines on the Right to a Remedy and Reparation for **Victims of Gross** Violations of International Human Rights Law and Serious Violations of International Humanitarian Law (UN, 2006)

- Proscribed types of compensation
 - restitution
 - rehabilitation
 - reparation
 - various forms of gratification (public apologies, commemorations, establishing facts, speaking out the truth etc.)
 - non repetition guarantees

For the victims of sexual violence in war, the Republic of Serbia has not provided **any** of the mentioned compensations.

Office of the war crimes Prosecutor (RS, 2003)

• Up until today there were *only two prosecutions* for sexual violence in war (in the 'Lekaj' and 'Bijeljina' cases), out of a total of six cases in which the accused were for these crimes as well (66 prosecutions in total).


Women in Black (1991) – feminist anti-war group from Belgrade, Serbia


